### Application packages are due by May 31, 2024.

### SCHOLARSHIP ELIGIBILITY REQUIREMENTS

- Enrolled as a full- or part-time rising or current junior or graduate student at an accredited college/university within the State of Georgia.
- Pursuing a degree in accounting, public or business administration, or finance.
- Earning a cumulative and major grade point average of 3.0 or greater on a 4.0 scale.
- Intention to pursue a career in the public sector, preferably the State of Georgia.
- Availability to attend one Georgia Fiscal Management Council meeting of your choice during the 2024-2025 enrollment year. (GFMC meetings occur once per month.)

#### APPLICATION SUBMISSION REQUIREMENTS

Completed application package MUST be received by May 31, 2024, including:

- 1. Completed Student Application Form.
- 2. Completed Departmental Chair Endorsement Form.
- 3. One written professional reference.
- 4. Written description of career goals, including why you desire to pursue a public sector career related to Fiscal Management or Administration within the State of Georgia.
- 5. Official college transcript sent by the college/university directly to the Scholarship Committee Chair listed below.
